### DIRECTIONS FOR USE

#### *Greens and Tees*

Apply three applications of **PBS150** at 5 ounces per 1000 ft<sup>2</sup> in 2 gallons of water (16L/ha in 800 L) at 30 day intervals. Irrigate after each application of **PBS150** to wash the surfactant off the leaf blades. Reapply **PBS150** after 150 days from last treatment, or as needed, if climatic conditions still exist for the formation of water repellency conditions.

#### *Fairways, Bunker Faces, Collars, Rough, Lawns and Sports Turf*

Apply **PBS150** at 8 ounces per 1000 ft<sup>2</sup> in 2 gallons of water (25 L/ha in 800 L). 10 to 14 days later apply a second application of **PBS150** at 8 ounces per 1000 ft<sup>2</sup> in 2 gallons of water (25 L/ha in 800 L). Irrigate after each application of **PBS150** to wash the surfactant off the leaf blades. Reapply **PBS150** after 150 days, or as needed, if climatic conditions still exist for the formation of water repellency conditions.

DO NOT combine **PBS150** in the spray tank with pesticides or fertilizers unless prior use has shown the combination physically compatible, effective and non-injurious under local conditions.
